Recruitment to the post of Medical officers in Junior Class – I of Odisha Medical & Health Service Cadre under Health & Family Welfare Department on Ad hoc basis

Applications in the prescribed proforma are invited from the prospective candidates for recruitment to 470 (Four hundred seventy) posts of Medical Officers in Junior Class – I rank of Orissa Medical Service Cadre under Health & Family Welfare Department in the pay band of Rs. 15,600 – 39,100/- plus grade pay of Rs. 5,400/- with usual dearness and other allowances sanctioned by Government of Orissa from time to time. The Medical Officers will continue on Adhoc basis for a period of one year w.e.f from the date of their joining at the place of posting or until recommendation of the OPSC for their regular appointment whichever is earlier. Their seniority will be counted from the date of O.P.S.C recommendation as per the merit list furnished to Government in that particular year.

- Out of the vacancies mentioned above, posts will be reserved for the physically Handicapped (Orthopedically handicapped candidates, who are capable of rendering service to the public), Ex-Servicemen and Sports persons as per ORV rule. Candidates belonging to P.H (Ortho), Ex-Servicemen & Sports persons shall be adjusted against the categories to which they belong.
- In the event of non-availability or availability of insufficient number of eligible women candidates belonging to any particular category the vacancies or the remaining vacancies will be filled up by male candidates of that category.
- In case of non availability of adequate number of reserved category candidates, recruitment of candidates from general categories may be made to fill up the vacancies.
- The number of vacancies to be filled up on the basis of this recruitment is subject to change by Government without notice, depending upon the exigencies of public service at the discretion of the State Government.

3. AGE:- A candidate must be under 32 (Thirty two) years and above 21 (Twenty one) years of age on the 1st Jan. 2013. The upper age limit is relax-able by 5 (five) years for candidates belonging to Socially & Economically Backward Classes (S.E.B.C), Scheduled Caste (S.C), Scheduled Tribe (S.T), Women and eligible Ex-Servicemen and by 10 (ten) years for P.H (O.H) candidates.

Provided that, a candidate who comes under more than one category mentioned above, he/she will be eligible for only one age relaxation benefit, which shall be considered most beneficial to him/her.

4. EDUCATIONAL QUALIFICATION:-

- (i) A candidate must be a Bachelor of Medicine and Bachelor of Surgery (M.B.B.S) from any Recognized University in the Indian Union or possess equivalent qualification or be a holder of a registerable medical qualification from a Medical College recognized by the MCI.
- (ii) After passing the final M.B.B.S examination, a candidate must have successfully completed internship for at least one year.
- (iii) In case he/she has acquired M.B.B.S degree from a Foreign University, he / she is required to have passed the screening test conducted by the National Board of Examination as prescribed by the Medical Council of India vide Notification No. MCI – 2003 (9) Regn. 2001 Dated. 13.02.2002 and must have completed one year of rotating internship in a recognized Medical College.
- (iv) A candidate must have registered himself / herself under the Orissa Medical Registration Act. 1961.

5. OTHER ELIGIBILITY CONDITIONS

- (i) The Candidate must be citizen of India
- (ii) The Candidate should be able to speak, read and write Odiya fluently and must have passed at least an examination in Odiya language equivalent to that of Middle English School standard conducted by the Board of secondary Education, Odisha or the Education Department of Government of Odisha or any other Board or Council of Secondary Education approved by the Government of Odisha in support of passing of Odiya Language Test (M.E school Standard)
