

COVID-19 has been declared as a Global Pandemic by WHO. More than 300 positive cases have been confirmed in India including 2 in Odisha. This number is likely to go up significantly in coming days as more than 3000 people have returned to Odisha from foreign countries and registered themselves in the COVID -19 portal of the State. This is an extraordinary situation which calls for extraordinary response. State Govt. has declared it a disaster. Govt. of India has also notified it as a disaster.

Keeping in the view of the urgency of the situation and as per Section 50 of the Disaster Management Act, 2005, Government has been pleased to constitute a State Level Emergency Procurement Committee with following members to take decision on the emergency procurement of drugs, equipment, consumables, computers etc. The Committee is authorised to approve the overarching principles for making emergency procurements and also take all procurement decisions without any financial limit.
