

This number is likely to go up significantly in coming days as more than 3000 people have returned to Odisha from foreign countries and registered themselves in the COVID -19 portal of the State. This is an extraordinary situation which calls for extraordinary response. State Govt. has declared it a disaster. Govt. of India has also notified it as a disaster.

Keeping in the view of the urgency of the situation and as per Section 50 of the Disaster Management Act, 2005, Government has been pleased to constitute a Committee for Bhubaneswar Municipal Corporation (BMC) with following members to take decision on the emergency procurement of drugs, equipment, consumables, etc.
