

Order

It is observed that there is increase in no of COVID-19 infection among health care workers in hospitals in recent times. Further it is observed during Death Audit that the documentation in the treatment records of admitted COVID-19 patients is inadequate. Therefore it is instructed to carry out the following instructions scrupulously.

1. Infection control practices at the facilities are to be assessed at regular intervals as per the check list enclosed (I&II) and must be optimally consolidated. The action taken report on the gaps observed must be suitably addressed and the compliance to be submitted to the under signed.
2. Any health care workers, Medical students, cleaning and line staffs working in the hospital with history of travel to other hotspot areas will be quarantined and subjected to rtPCR Test on 5th day of arrival. Further course of action is to be adopted as per established protocol.
3. The clinical records are to be maintained properly in the treating facilities. The case records of a diagnosed COVID-19 positive case are to be sent within 24 hours of death to dhsodisha@gmail.com along with an inhouse death audit report.
4. The new guideline on Clinical Management of COVID-19 case issued by MoHFW, Govt are to be followed judiciously.
5. All health care facilities are instructed to ensure creation of dedicated Fever Clinic and Isolation facilities for suspected and suspected or diagnosed COVID-19 cases as directed earlier.
