In exercising the power conferred under Section-2 of the Epidemic Disease Act.-1897 and in conformity with Rule-17 of guidelines issued by the Press Council of India, the State Government have been pleased to issue the regulations / advisory for prevention of Novel Corona Virus (COVID-19) as under.

 The security and safety of the affected person, his/her relatives, treating doctor, assisting medical staff is of paramount importance in the emerging situation. Hence, confidentiality of the information relating to the affected persons, his/her relatives, treating doctors, assisting medical staff and the residential address of the person and relatives are to be kept confidential.

Therefore, no media shall publish the name and address of the person infected / affected with COVID-19 Virus, his/her parents, relatives, the doctor treating the patient and the assisting medical staff, obtained through any source, in any Print / Electronics / Web / Social Media.

2. That no media shall interview any patient affected with COVID-19, his/her parents / relatives / treating doctors, assisting medical staff, in any form.

Any person disobeying any regulation or order made under the above provisions shall be deemed to have committed an offence punishable under Section-188 of IPC as per Section-3 of the Epidemic Disease Act.-1897.
