Sub : Periodic Health Screening of Fire Service Personnel deployed in COVID treatment facilities.

Madam/Sir,

In inviting a reference to the subject cited above, I am to say that during the resurgence of the COVID-19 in its 2nd wave in the State, large numbers of Fire Service personnel have been deployed in various COVID treatment facilities for maintaining fire safety of the Hospitals and also engaged in Sanitizations Work. Keeping them physically fit to perform their duties during the present emergency situation and also considering the proposal of the D.G, Fire Services, it is hereby ordered that the periodical health check up of the Fire Service personnel may be taken up in their respective districts. Besides, they may also be provided with PPE Kits and other required accessories during their duties in Covid treatment facilities and any other COVID related work. The Assistant Fire Officer of the District will act as nodal officer and make liaison with the identified Health Officials to organize the testing and other arrangements.

It is, therefore, requested to undertake the following periodical tests and other desired/recommended test through the existing network of Hospitals of Health Department at District level .

1. Blood: CBC or Hemoglobin, DC, TLC, ESR, TPS, FBS, PPBS, Blood Urea, Serum, Creatinine, Liver Function Test (LFT), Pulmonary Function Test (PFT), Lipid Profile, TSH, HbAC.


2. Urine Test: Routine/Microscopic
3. General Test: Height, Weight, BMI, BP
4. Cancer Screening: Breast & Oral Cancer
5. ECG & X-ray of Chest.
