Madam/Sir,

With reference to the subject & reference cited above, I am to say that, Government of India has announced the Liberalized and Accelerated Phase-3 Strategy of COVID-19 Vaccination, which will commence from 1st May 2021 across the country.

Henceforth, the COVID-19 Vaccine will no longer be supplied to Private CVCs after 30th April 2021 and unused vaccine stocks must be returned back to concerned CCP/DVS on 30th April 2021 after ending the session in Private CVCs.

The District must reconcile the COVID-19 vaccine supplied to all the Private CVCs by 30th April as per format (**enclosed**) and consolidated data shall be kept for audit purposes.

You are therefore requested to ensure above instructions immediately in your district.
