Successful bidders will make payments on March 15, 2017 before close of banking hours by means of cash, bankers' cheque / pay order, demand draft payable at Reserve Bank of India, Mumbai/Bhubaneswar or a cheque drawn on their account with Reserve Bank of India, Mumbai (Fort) / Bhubaneswar. The loan will be repaid at par on March 15, 2032. The cut-off yield determined at the auction will be coupon rate per cent per annum on the Stock sold at the auction.
