## **ORDER**

Pursuant to lockdown orders issued by Govt. of Odisha vide letter No.8980/H&FW, dtd.24.03.2020 as well as its various modifications subsequently and the order No.40-3/2020, dtd.24.03.2020, nationwide lockdown has been imposed for three weeks up to 25th April, 2020.
