## NOTIFICATION

No. TRN-LC-MISC-0028-2021/ 4467 /T., In exercise of the powers conferred by sub-section (1) of section 67 of the Motor Vehicles Act, 1988 (59 of 1988) and having regard to the provisions of clauses (a) to (d) of the said sub-section, the State Government do hereby issue the following directions to the State Transport Authority, Odisha, the Regional Transport Authorities, the ambulances of private Hospitals and the private ambulance operators functioning in the in the State.

#### **DIRECTIONS**

1. The maximum hiring charges for Patient Transport Ambulance (PTA), Basic Life Support (BLS) ambulance and Advance Life Support (ALS) ambulance operating across the State of Odisha is fixed as specified in the Schedule below with effect from the date of issue of this Notification.

- 2. The proposed maximum rates include Oxygen, Ambulance Equipment, PPE Kit, Gloves, Mask, Face Shield, Sanitization, Driver, Emergency Medical Technician (EMT) (where required)
- However, for administration of any medication (injectable/oral) including Oxygen onboard, the additional cost is to be charged as per actual.
- 4. The hiring charges for Patient Transport Ambulance (PTA), Basic Life Support (BLS) ambulance and Advance Life Support (ALS) ambulance shall be revised from time to time, based on changes in fuel prices in the State.

The Transport Commissioner is authorized to issue necessary order on revision of hire charges of ambulances taking into account the increase/decrease in fuel prices as is being done for stage carriage buses.

Any deviation of the above hire charges shall be dealt as per section 72 read with section 192A of the M.V. Act, 1988
