In compliance with order dated 15.7.2022 of the Hon'ble High Court in W.P.(C) No.17325 of 2020 filed by Dr. Abinashi Sabyasachi Sethy-vrs.-State of Odisha & Others, and on the recommendation of the Odisha Public Service Commission pursuant to the advertisement No. 12 of 2018-19, the following candidate is appointed as Assistant Professor in the discipline of Paediatrics under OMES Cadre of Health and Family Welfare Department in the Academic Level 12 of First Schedule of this Department Notification No.33012 dated.16.12.2019 with other allowances as admissible from time to time from the date of his actual joining in the post or until further orders.

1. The appointment is purely temporary and terminable at any time without prior notice and without assigning any reason thereof.
2. Upon such appointment, the appointee is posted in the Medical College, as mentioned against his name, initially against the vacant post under OMES Cadre. The service is transferable and comes under the purview of the transfer policy for posting in other Government Medical Colleges, as and when required.
3. The appointee shall be on probation for a period of one year.
4. The appointee shall be treated at par with the appointees those were appointed as per the recommendation of the OPSC pursuant to the advertisement No.12 of 2018/2019 vide H&FW Department Notification No. 13073 dated 5.6.2020. However, he shall be given the notional benefit of pay and seniority after he actually joins service as Assistant Professor, Paediatrics in OMES cadre, as per the inter se merit of the petitioner i.e. being the last amongst the candidates of SC (Men) category in the discipline of Paediatrics.

In case the appointee belongs to OMHS cadre, he is required to furnish his details of past engagements ( name of the post, nature (Temporary, Permanent), type (Deputation or Deployment) and Name and Address of the Institute) within 07 (seven) days from the issue of this Notification through email i.e. [medicaleducation1odisha@gmail.com](mailto:medicaleducation1odisha@gmail.com) for taking necessary steps for his early relieve from Medical College and Hospitals of the State of Odisha /acceptance of his resignation from OMHS Cadre.

The appointee is directed to join at his place of posting within 30 (thirty) days positively from the date of issue of the notification on the production of the order of acceptance of his resignations/ relieve orders from the competent authorities failing which the offer of appointment shall lapse automatically.
8. The Dean & Principal of the respective Medical College is requested to accept the joining report of the appointed doctor after due verification of relieving order/ acceptance of the resignation, if any, by observing due procedure as per Rules and Regulations.
