1. The appointment is purely temporary and terminable at any time without prior notice and without assigning any reason thereof.
2. Upon such appointment, the appointee is posted in the Medical College, as mentioned against his name, initially against the vacant post under OMES Cadre. The service is transferable and comes under the purview of the transfer policy for their posting in other Government Medical Colleges, as and when required.
3. The appointee shall be on probation for a period of one year.
4. The appointee shall be treated at par with the appointees those were appointed as per the recommendation of the OPSC pursuant to the advertisement No.12 of 2018/2019 vide H&FW Department Notification No. 13073 dated 5.6.2020. However, he shall be given the notional benefit of pay and seniority after he actually joins service as Assistant Professor, O&G in OMES cadre, as per the inter se merit of the petitioner i.e. being the last amongst the candidates of ST category in the discipline of O&G.

The appointee is directed to join at his place of posting within 30 (thirty) days positively from the date of issue of the notification on production of order of acceptance of his resignations/ relieve orders from the competent authorities failing which the offer of appointment shall lapse automatically.
8. The Dean & Principal of the respective Medical College is requested to accept the joining report of the appointed doctor after due verification of relieving order/ acceptance of the resignation, if any, by observing due procedure as per Rules and Regulations.
