On the recommendation of the Odisha Public Service Commission, Cuttack vide their letter No. 7016/PSC, dated-30.07.2022, Dr. Suman Tripathy is hereby appointed and posted as Dental Surgeon at CHC, Bankoi, Khordha in the rank of Group-A' (Junior Branch) of the Odisha Medical Services (Dental) Cadre under Health and Family Welfare Department in the scale of pay of Rs.56, 100/- (cell 1 of Level 12 of Pay Matrix of ORSP Rule 2017 ) and other allowances as admissible and sanctioned by Government from time to time.

1. The appointment is purely temporary and terminable at any time without prior notice and without assigning any reason thereof.
2. The appointment is subject to her medical fitness to be determined by the Medical Board and her characters, antecedents are found to be satisfactory after verification. In case, adverse reports are received, the service of the candidate concerned would be terminated forthwith.

The appointee is requested to download the copy of this Notification from the website and produce the same before the concerned COM & PHO within 15 days of issue of this Notification along with her joining report, failing which, her appointment shall be automatically terminated.
4. If the appointee will fail to produce the Original Registration Certificates as per the OPSC Advertisement No-15 of 2017-18 before the concerned CDM & PHO within 15 days of issue of this Notification, her appointment order will stand terminated.
5. No T.A. / D.A. will be allowed to join the place of posting.
6. In the event of non-existence of a vacancy at a particular place / institution, the concerned CDM & PHO will accept the joining report and will adjust the Dental Surgeon against any other vacancy available under his disposal. It will be the responsibility of the CDM & PHO to furnish necessary proposal to Government for issue of revised order forthwith.
7. The Dental Surgeon shall not be relieved by the concerned CDM & PHO from her place of posting without prior permission of the Government for JR / PG / SR / DNB, if selected in future.
