## Roles & Responsibilities of the State Steering Committee :

- The role and responsibility of the State Steering Committee are to set priority in workflow, support, guide and oversee the general course of its operation to achieve the proper treatment and post-operative care of Liver Transplantation Patients (Adults & Paediatric).
- It is the key body within the Governance Structure which is responsible for ensuring the
  delivery of the operational output of the agency/hospital concerned for smooth
  operation/transplantation and the efficient attainment of visible outcomes.
- The Committee will sit as and when required. In addition, the further roles and responsibilities shall include monitoring of :
  - quality/skill in screening, treatment, the procedure of transplantation & post-operative treatment of the patients.
  - o achievements within the timelines.
  - modalities to be followed to achieve the functionalization of liver transplant and visible outcomes and activities for smooth management.
  - budgetary allocation and defining the additional budget requirement that may be essential for the continuation of the transplantation program.
  - the decision for continuation or pre-mature termination of assignment of agency for Liver Transplantation (Adult & Paediatrics) on the basis of outcomes.

## Roles & Responsibilities of the State Management Committee

The State Management Committee has ultimate responsibility for the activities of the agency in Liver Transplantation (Adult & Paediatrics) for ensuring that it is well run and delivering the outcomes for which it has been set up. The basic role & functions are outlined as under.

- To provide complete and suitable infrastructure for implementation/ functionalization of the scheme.
- To ensure that doctors from the agency team conduct monthly clinics at the Government Hospital for the pre and post-transplant evaluation and care of patients (Adult & Paediatric)
- To provide permission to conduct Continued Medical Education (CMEs) for Pediatricians to identify and manage advanced Paediatric Liver disease who may benefit from transplantation.
- To ensure inter & intra-departmental coordination.
- Monitoring the activities/skill of the agency and ensuring they work keeping the principle, objects, and values as per the scope of work.
- Scrutinize the claim of the Agency vis-a-vis the cases/operation outcome and recommend for release of funds by the authority for purpose of settlement of claims.

The Committees may nominate/ invite/ co-opt such other persons to the Committee as may be considered useful.

This has the kind approval of the Hon'ble Minister, Health and Family Welfare.
