No. 4370 IH- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha hereby makes the following rules to amend the Odisha Food Testing Laboratory Cadre (Methods of Recruitment and Conditions of Service) Rules, 2021, namely:

- Short title and commencement.— (1) These rules may be called the Odisha Food Testing Laboratory Cadre (Methods of Recruitment and Conditions of Service) Amendment Rules, 2022.
 - (2) They shall come into force on the date of their publication in the Odisha Gazette.
- In the Odisha Food Testing Laboratory Cadre (methods of Recruitment and conditions of Service) Rules, 2021, (hereinafter referred to as the said rules), in rule 2, in sub-rule(1), for clause(C), following clause shall be substituted, namely:-
 - (C) "Commission" means the "Odisha Staff Selection Commission";
- 3. In the said rule, for the words "Odisha Subordinate Staff Selection Commission" wherever they occur, the words "Odisha Staff Selection Commission" shall be substituted.
