Applications are invited from eligible candidates in the prescribed proforma for the post of Director, VSS Institute of Medical Sciences and Research, Burla Sambalpur, Odisha, in the scale of pay of academic level 14 of First Schedule as per the Odisha Revised Scales of Pay (For Medical College Teachers) Rules, 2019 vide this Department Notification No.33012 dated 16.12.2019) + administrative allowance of Rs.5,000/- per month plus financial incentive at the rate admissible to the equivalent rank in the concerned discipline posted at VIMSAR, Burla for in-service candidates, (Rs.1,25,000/- per month for Speciality Discipline and Rs. 2,00,000/- per month for Super Speciality Discipline), OR a consolidated remuneration of Rs.2.0 lakh per month including all other allowances/charges for retired candidates, or a consolidated remuneration of Rs.2.5 lakh per month including all other allowances and charges for direct candidates who have not worked in any Government system. The appointment shall be for a term of three years from the date on which he/she enters upon his/her office or till he/she attains the age of sixty-five years, whichever is earlier. The incumbent shall also be eligible for reappointment for another term of three years or till he/she attains the age of sixty-five years, whichever is earlier.

A. Eligibility: To be eligible a candidate must have the following criteria.

1. Essential Qualification & Experience:

"Should possess the recognised postgraduate medical qualification and other academic qualification from a MCI recognized institution with a minimum of ten years' teaching experience as Professor/ Associate Professor/ Reader in a Medical College/Institution, out of which at least five years should be as Professor in a department. Preference for these appointments may be given to the Heads of the Departments."

- 2. Upper Age Limit: No person, who has completed sixty two years of age by **01.01.2023**, shall be eligible to apply.
- B. Person employed in Government Departments, Autonomous Organisations and Public Sector Undertakings, should send their application, along with a NOC (No Objection Certificate) from their appointing authority.

A copy of such intimation shall be enclosed with the application form.

C. The application in the prescribed format, complete in all respects along with the required documents must be sent by **Speed post or Registered post** to the "Additional Secretary to Government (Medical Education-I), Health & FW Department, Lok Seva Bhawan, Bhubaneswar, 751001, Odisha/ e-mail (orhealth@nic.in and medicaleducation1odisha@gmail.com) so as to reach on or before **20.04.2023**, **5.00 PM**.
