In continuation of Health and Family Welfare Department Notification No-20622, dated-09.08.2018 and Notification No-23387, dated-12.09.2018, the Medical Officers of the OMHS cadre having DNB broad speciality and DNB super speciality qualification granted in a medical institution with attached hospital or in a hospital with the strength of five hundred or more beds, by the National Board of Examinations (as per Para 37(2) of the National Medical Commission Act 2019) are hereby allowed the following financial benefits as incentives.

 Medical Officer having qualification of DNB broad speciality as per Para 37(2) of the National Medical Commission Act 2019. Rs. 20, 000/- PM (Rupees Twenty Thousands) per month

 Medical Officer having qualification of DNB super speciality as per Para 37(2) of the National Medical Commission Act 2019. Rs. 30, 000/- PM (Rupees Thirty Thousands) per month

Further, Point No. 3 (iv) of this Department Notification No. 20622, dt. 09.08.2018 is here by modified as "Doctors of OMHS cadre working in Medical Colleges on deputation/deployment basis shall also avail this incentive".

This will be effective from the date of issue of this notification.
