The NMC has issued "Teachers Eligibility Qualifications In Medical Institutions Regulations, 2022" governing eligibility qualifications of Teachers, Directors, Deans & Principals, and Superintendents of Medical Colleges. Regulation 3.7 of the same says,

"xxxxx Medical Superintendent shall not occupy the position of the Head of the Department. xxxxx"

Pursuant to the above Regulations of NMC, the Superintendent, SVPPGIP, Cuttack shall not occupy the position of the Head of the Department. The policy Resolution regarding rotational headship for the Post of HoD in Government Medical Colleges of the State vide Resolution No. 20994 dated 19th July 2013 shall be followed for HoDs of Paediatrics and Paediatrics Surgery Department of SCB MCH, Cuttack, and SVPPGIP, Cuttack.

This supersedes this Department DO Letter No. 25809/SHFW dated 04.12.2015.
