**NOTIFICATION**

On the recommendation of the Odisha Public Service Commission, Cuttack vide their letter No. 3119/PSC, dated 03.04.2023, 6 (Six) number of candidates are hereby appointed as Medical Officers in the rank of Group-'A' (Junior Branch) of Odisha Medical & Health Services Cadre under Health and Family Welfare Department and posted to the districts as mentioned against each in the scale of pay of Rs.56,100/- (Level-12, Cell-1 of the Pay matrix) as per the ORSP Rules, 2017 and other allowances as admissible and sanctioned by the Government from time to time. They shall be on probation for a period of two years from the date of joining the post.

- 1. The appointments are purely temporary and terminable at any time without prior notice and without assigning any reason thereof.
- 2. The appointees who will fail to produce the original Certificates as per the OPSC Advertisement No- 11 of 2022-23 before the concerned CDM & PHOs and in the event of any forged document comes to the notice of the verifying authority, their appointment orders will stand terminated.
- 3. The appointments are subject to their medical fitness to be determined by the Medical Board and their characters, antecedents are found to be satisfactory after verification. In case, adverse reports are received, the services of the candidates concerned would be terminated forthwith.
- 4. As reported by the Odisha Public Service Commission, Dr. Pallikala Sisil Reddy bearing roll No. 101320 (Sl. No. 2) has not passed Odia up to M.E. School Standard.

As per the Rule 7(v) of Odisha Medical &Health Services (Method of Recruitment and Conditions of Service) Rules, 2017 and Odisha Medical & Health Services Amendment (Method of Recruitment and Conditions of Service) Rules, 2020, he/she shall be allowed to pass the said examination conducted by Board of Secondary Education, Odisha within 04 (Four) years of joining in the service failing which no further increment shall be sanctioned and no promotion to the rank of Group-A (Senior Branch) will be made.

- 5. No T.A. / D.A. will be allowed to join the place of posting.
- 6. The Medical Officers allotted to different districts will be posted to different health facilities of the district by a Committee under the Chairmanship of Collector-cum-DM and the CDM&PHO will be the convener of the committee along with wing officers as members.
- 7. The Medical Officers who are continuing their PG study or any higher study or working as Senior Resident or contractual Assistant Professor are selected for regular appointment on the recommendation of the OPSC may be allowed to join at the place of their posting in the periphery and may be relieved by the concerned CDM & PHO on the next day in order to enable them to continue their PG study or any higher study or their Senior Resident ship or contractual Assistant Professor in the respective Medical Colleges on submission of an undertaking to join and serve under the State Government at the place of posting on completion of their higher studies .The Medical Officers who are working as Tutor or JR and selected for regular appointment on the recommendation of the OPSC may be allowed to join at their place of posting in the periphery after their resignation from the post of JR or Tutor.

8. The Medical Officers while working in the periphery service in case selected for P.G study or any higher study or for undergoing Senior Resident ship / Tutorship / JR ship in future through the counselling will not be relieved by the concerned CDM & PHO to join the course without obtaining prior permission of the Government.
