Sub: Restructuring & Corresponding Revision of Pay Structure of Odisha Laboratory Technician Service Cadre of the Health & Family Welfare Department

In view of the increase in number of public health facilities, increase in patient load at Government Hospitals, Government after careful consideration have been pleased to restructure the Odisha Laboratory Technician Service Cadre in public interest for smooth and efficient functioning of health care facilities in following manner.

The detailed analysis of the Restructured Odisha Laboratory Technician Service Cadre:

 Out of sanctioned strength of 2235 base level posts of Laboratory Technician in the scale of pay of Rs.25,500-81,100/- (Level-7 under ORSP Rules, 2017), 790 posts shall stand abolished in lieu of creation of 1030 posts at different levels in the cadre hierarchy leaving 1445 posts at base level. The base level post of Laboratory Technician shall be re-designated as Medical Laboratory Technician (MLT).

2. The existing 100 posts of Senior Laboratory Technician in the scale of pay of Rs.35,400-1,12,400/- (Level-9 under ORSP Rules, 2017), shall be redesignated as Technical Officer (MLT), Level-II at the same pay level.

In addition to this, 623 posts of Technical Officer (MLT), Level-II shall be created arriving at a total of 723 posts, which is the 1st promotional hierarchy in the cadre.

3. The existing 6 posts of Technical Supervisor in the scale of pay of Rs.44,900-1,42,400/- (Level-10 under ORSP Rules, 2017), shall be re-designated as Technical Officer (MLT), Level-I at the same pay level.

In addition to this, 305 posts of Technical Officer (MLT), Level-I shall be created arriving at a total of 311 posts, which is the 2nd promotional hierarchy in the cadre.

- 4. There shall be creation of 101 posts of Chief Technical Officer (MLT) in the scale of pay of Rs.47,600-1,51,100/- (Level-11 under ORSP Rules, 2017), which is the 3rd promotional hierarchy in the cadre.
- 5. There shall be creation of 1 (one) post of Assistant Director in the scale of pay of Rs.56,100-1,77,500/- (Level-12 under ORSP Rules, 2017), which is the 4th promotional hierarchy in the cadre.
- 6. The total cadre strength will be 2581.

Necessary changes in Odisha Laboratory Technician Service (Methods of Recruitment and Conditions of Service) Rules, 2019 will be made by this Department in due course.

This will come into force with effect from the date of issue of this Resolution in the ODISHA GAZETTE.
