Subject :- Restructuring & Corresponding Revision of Pay Structure of Odisha Multipurpose Health Worker(Male) Service Cadre of Health & Family Welfare Department.

In view of the increase in number of public health facilities, increase in patient load at Government Hospitals, Government after careful consideration have been pleased to restructure the Odisha Multipurpose Health Worker (Male) Cadre in public interest for smooth and efficient functioning of health care facilities in following manner.

The detail analysis of the Restructured Odisha Multipurpose Health Worker (Male) Service Cadre

- 1. The existing 4941 posts of MPHW(M) at the base level at Pay Level-5 under ORSP Rules, 2017, shall be re-designated as MPHW(M), L-II. In addition to this, there shall be creation of 1747 no of MPHW(M), L-II posts, thereby arriving at a total of 6688 posts of MPHW(M),L-II at the base level.
- 2. There shall be creation of 3267 posts of MPHW(M),L-I at Pay Level-9 under ORSP Rules, 2017 at the 2nd level of the restructured cadre hierarchy/ promotional hierarchy.
- 3. The existing 1597 posts of MPHS(M) at Pay Level-9 under ORSP Rules, 2017, shall be upgraded to the next higher scale, i.e. to Pay Level-10 under ORSP Rules, 2017 and the existing MPHS(M) posts will be re-designated as MPHS(M), L-II. In addition to this, there shall be creation of 393 no of posts of MPHS(M), L-II at Pay Level-10, thereby arriving at a total of 1990 posts of MPHS(M),L-II at the 3rd level of the restructured cadre hierarchy/ promotional hierarchy.

The existing MPHS(M)s at Pay Level-9 under ORSP Rules, 2017 and getting a basic pay less than or equal to Rs 44,900 will get the initial basic pay as in Cell-1 of Level-10 as per ORSP Rules, 2017, after their upgradation to MPHS(M), L-II at Pay Level-10 under ORSP Rules, 2017. Further, the existing MPHS(M) at Pay Level-9 under ORSP Rules, 2017 and getting a basic pay more than Rs 44,900 will simply be placed at the corresponding pay level in Level-10 under ORSP Rules, 2017, without any fixation of pay/increment.

- 4. There shall be creation of 395 no. of posts of MPHS(M),L-I at Pay Level-11 under ORSP Rules, 2017 at 4th level of the restructured cadre hierarchy/promotional hierarchy.
- There shall be creation of 01 post of Assistant Director at Pay Level-12 under ORSP Rules, 2017 at 5th level of the restructured cadre hierarchy/ promotional hierarchy.
- 6. After restructuring, the total cadre strength will be 12341.

Necessary changes in Odisha Multipurpose Health Worker (Male) Service Cadre Rules, 2019 will be made by Health & Family Welfare Department in due course.

This Resolution shall come into force with effect from the date of publication of the Gazette Notification.

This has been duly concurred in by the Finance Department in their OSWAS File No. FIN-SOS3- ESTT-0014-2023 and communicated to Health & FW Department vide File No. PT1-HFW-FW-FWMISC-0091-2022 and concurred in by the GA & PG Department in OSWAS File No. GAD-SC-GCS-0252-2023.
