**RESOLUTION**

**Sub: Restructuring & Corresponding Revision of Pay Structure of Odisha Homeopathic Medical Service Cadre of the Health & Family Welfare Department**

In view of the upgradation of AYUSH Dispensaries to Health & Wellness Centres, in order to ensure proper monitoring of dispensaries and also to encourage promotional avenues of the Medical Officers of the cadre, Government after careful consideration have been pleased to decide for restructuring of the Odisha Homeopathic Medical Service Cadre in public interest for smooth and efficient functioning of health care facilities in the Homoeopathic Hospitals and Dispensaries of the State, in the following manner.

1. Out of the existing sanctioned strength of 595 base level posts of Homoeopathic Medical Officer in the scale of pay of Rs. 44,900/- to 1,42,400/- (Level-10 under ORSP Rules, 2017), 196 posts shall stand abolished in lieu of creation of 213 posts at different levels in the cadre hierarchy leaving 399 posts at base level.
2. There shall be creation of 196 posts of Senior HMO in the scale of pay of Rs.56,100/- to Rs.1,77,500/- (Level-12 under ORSP Rules, 2017) which is the 1st promotional hierarchy in the cadre.
3. In addition to the existing 17 nos. of District Homoeopathic Medical Officer/Dy. Supt./CMO post, 15 posts of District Homoeopathic Medical Officer (DHMO) in the scale of pay of Rs.56,100/- to Rs.1,77,500/- (Level-12 under ORSP Rules, 2017) shall be created arriving at a total of 32 posts, which is the 2nd promotional hierarchy in the cadre.
4. In addition to the existing 01 post of Deputy Director(Homoeopathy) in the scale of pay of Rs.67,700/- to Rs.2,08,700/- (Level-13 under ORSP Rules, 2017) another post of Deputy Director(Homoeopathy) Level-13 shall be created arriving at a total of 2 posts, which is the 3rd promotional hierarchy in the cadre.
5. There shall be creation of 1 post of Joint Director(Homoeopathy) in the scale of pay of Rs.78,800-2,09,200/- (Level-14 under ORSP Rules, 2017), which is the 4th promotional hierarchy in the cadre.
6. The total cadre strength will be 630 as detailed in the table overleaf:
