



# **Odisha State Tele Awards Rules, 2013(Amended in 2023)**

## **1. SHORT TITLE AND COMMENCEMENTS**

- (i) These Rules shall be called - The Odisha State Tele Awards Rules, 2013  
(Amended in 2023).
- (ii) These Rules shall come into effect from the date of Notification of the Rules.
- (iii) This supersedes all previous Rules.

## **2. AIMS AND ELIGIBILITY**

- i. The Scheme of State Tele Awards aims at encouraging the production of Tele Serials in Odia and Tribal language of Odisha included in Schedule-8, of aesthetic excellence, high technical standards and social relevance.
- ii. The Scheme of State Tele Awards envisaged under these rules shall apply to Tele Serials produced in Odia and Tribal language of Odisha included in Schedule-8. In case of Tele Serials in Tribal Language, its subtitled copy is required for assessment.
- iii. Subject to provisions of these Rules, the Tele Serials shall be eligible for consideration of awards which are in Odia Language & Tribal Language of Odisha that have been telecast between 1st January to 31st. December of the year to which the award relates. The Producer of the Tele Serial need to submit soft copy of the Serial for a duration of 2 hr. 30 minutes to 3 hrs. which should contain the materials of at least 52 episodes telecast in a Calendar year from 1st. January to 31st. December. Certificate from T.V channel concerned must be submitted by the Producer regarding telecast of the Tele Serial and the number of episodes telecast during the year. Besides, the Producer should also illustrate in clear-cut terms the specific category/ categories of awards for which he / she has applied for. Further a ten minute clippings in soft copy on the category / categories of awards applied for must also be submitted for enabling the Jury Committee to take their valued decision.

## **3. The following Tele serials shall be ineligible for entry**

- a. Remake of a Tele serial that has already own a State Award in a particular category.
- b. Dubbed/ revised/ copied/ remake version of a Tele Serial.
- c. Tele Serials that relates to threat to National Integrity, Sovereignty and Religious harmony.
- d. Performance of an artist where his/ her voice and dialogue are dubbed by some other artist(s).



#### 4. Awards

- a. The awards which will be given are indicated in Schedule-I to these Rules. This shall be rearranged as and when necessary.
- b. Violation of provision of this Rules or Copy Rights Act if proved will disqualify the Odisha State Tele Awards or will result in cancellation of the award if won at any time with adequate penalty as decided by Government.

#### 5. LAST DATE FOR RECEIPT OF ENTRY

Last date for receipt of application for awards envisaged under this Rule along with the soft copy of the Serial shall be as provided in the advertisement issued.

#### 6. PROCEDURE FOR ENTRY OF TELE SERIALS.

- (i) The Tele serial shall be entered only by its Producer or by any one authorised by the Producer.
  - (ii) A Tele Serial may be entered for all the awards or for any one category.
7. The producer shall submit his/her entry in the Entry Form given in Schedule- II to these Rules in duplicate. The Form shall be complete in all respect and shall be accompanied by all materials mentioned in Rule 8 failing which the entry is liable to be rejected.

#### 8. The following shall be furnished along with the Entry Form

- (a) A soft copy of the Tele serial as certified by self authorisation from the concerned producer of the Tele Serial.
- (b) A non refundable entry fee of Rs. 3000/- in favour of the Director, Odia Language, Literature and Culture Department (subject to change of amount as and when necessary).
- (c) 10 copies of the text of the commentary in the original language
- (d) Short biographical sketches of the Producer, Director, Screen play writer, leading and supporting Artists, Cameraperson, Audiographer, Editor provided that if a Tele serial is being entered for specific award/ awards, biographical sketches should relate to the persons who are to be applied for Award by the Producer.
- (e) Undertaking by the Producer in non-judicial stamp paper that the Tele serial does not contain any obscence or objectionable materials detrimental to socio-cultural integrity and anti-government campaign. In case of detection of such

incident, the award(s) so conferred will be withdrawn from the concerned awardee.

(f) Attested copy of Certificate from T.V channel concerned regarding telecast of the Tele serial along with number of episodes telecast in the year.

(g) Synopsis for a duration of 2 hr. 30 minutes to 3 hour in softcopy which should contain the materials of at least 52 episodes telecast in a Calendar year from 1st. January to 31st. December of the year to which the Award relates. A ten minute clippings on the category / categories of awards applied for must also be submitted in another soft copy.

(h) Undertaking by the Producer and the Director in non-judicial stamp paper that the Tele Serial is original and is not a dubbed/revised/copied/remake version of any Tele Serial.

(i) Undertaking by the Story writer in non-judicial stamp paper that the story of the Tele Serial is original and is not a revised/copied version of any Tele serial.

(j) Authorisation by the Producer, in case the Producer is not the Applicant.

(k) 10 copies of the lyrics, if any in original language containing the name of the Lyricist, Singer and Music Director.

9. The cost of sending the soft copy of the Tele Serial and other materials to the Directorate of Odia Language, Literature and Culture shall be borne by the applicant.

10. The Department reserves the right to reject any entry if the soft copy of the Tele serial and other documents prescribed under this rules are not received by the prescribed date and time.

#### 11. **PROCEDURE FOR SELECTION**

i. The award shall be decided by a Jury to be constituted for each year.

ii. The Jury shall be composed of a Chairperson and not more than six members distinguished in the field of Tele serials, performing and other allied art forms.

iii. Any person directly or indirectly associated with Tele Serials entered for consideration of the Award shall not be eligible to act as a member of the Jury.

iv. A member of Odia language, Literature and Culture Department or any of the Sub-ordinate Office of Odia Language, Literature and Culture Department shall not be eligible to act as a member of the Jury.

v. Cine journalist having their own cinema publication and provision of independent award declaration/ function shall not be eligible to act as a member of the Jury.

vi. The Chairperson of the Jury should be a person having association with Cinema and knoweldge about Tele serial or performing arts of any kind.

vii. The Jury will determine their own assessment procedure.

viii. The Chairperson of the Jury may seek advice of the experts in specialized areas

whenever necessary.

- ix. The quorum for the meeting of the Jury shall be 50% of the members of the Jury and the Chairperson.
- x. In case of difference of opinion, the opinion of the majority of the members of the Jury including the Chairperson shall be deemed to be the recommendation of the Jury. In the event of equality of votes, the Chairperson shall have a casting vote.
- xi. The jury shall have the discretion to recommend that any one or more awards may not be given for a particular year if they are of the opinion that entries for that or those awards are not of the required standards.

xii. The Producer of the Tele serial need to submit softcopy of the serial for a duration of 2 hr. 30 minutes to 3 hour which should contain the materials of at least 52 episodes telecast in a Calendar year to which the Award relates. A ten minute clippings

on the category of awards applied for must also be submitted in soft copies.

xiii) The Tele Serial once awarded under category of "Best Tele Serial Award" shall not be awarded "Best Tele Serial Award" for the subsequent three years in succession.

But can participate for awards under other categories.

12. The Tele Serials in respect of which valid entries have been made shall be screened for the purpose of selection of awardees at such place and time as may be determined by the Director, O.L.L & C in consultation with the Chairperson of the Jury.
13. The awards shall be presented on such date and place as decided by the State Government.
14. The soft copy of the Tele serial shall be sent at the owner's risk and neither the State Government nor the Jury shall be responsible for the loss or damage to the soft copy while in dispatch.

#### 15. **GENERAL**

- a. Government shall have right to amend/ modify the above Guidelines from time to time to make these rules operational.
- b. No contestant should claim their own merit over others.
- c. Decision of the Jury shall be final and cannot be challenged in the Court of Law. However the Department may review the decision of the Jury in case of any dispute and the decision of the Review committee shall be final.
- d. The decision of the State Government in respect of matters covered by these Guidelines and all the interpretation of these rules shall be final.

#### 16. **LIFETIME ACHIEVEMENT AWARD OF AN ODIA TELEVISION PERSONALITY.**

A separate Board consisting of three members who have been honoured with Jayadev Award in the past may decide upon such Award. A representative of the Odisha Tele Actors Association who is not part of the competition may be included in the Board.
