On the recommendation of the Odisha Public Service Commission pursuant to the advertisement No. 16 of 2022-23, the following candidates are hereby appointed temporarily as Assistant Professors in the discipline of General Surgery under OMES Cadre of Health and Family Welfare Department in the Academic Level 12 of First Schedule of this Department Notification No.33012 dated.16.12.2019 with other allowances as admissible from time to time from the date of their actual joining in the post until further orders.

- 1. The appointment is purely temporary and terminable at any time without prior notice and without assigning any reason thereof. Their service is transferable and comes under the purview of the transfer policy for their posting in any Government Medical Colleges, as and when required.
