NOTIFICATION

In pursuance of powers conferred under clause(b) of section-3 and sub-section-(4) of section 7C of the Orissa Education Act, 1969 (15 of 1969) read with the Orissa Education (Payment of Grant-in-Aid to High Schools, Upper Primary Schools, etc.) Order, 2004 and subsequent amendments thereof and Odisha Education (Payment of Grant-in-Aid to High Schools, Upper Primary (ME) Schools, Sanskrit Tols and Madrasas) Order, 2013, the State Government do here by notify the following private educational institutions(Madrasas) as eligible to receive Grant-in-Aid subject to the terms and conditions mentioned below from the date of its notification in the Odisha Gazette.

1. The roll strength of each class of each school need to be certified by the concerned Inspecting Authority at the beginning of the teaching session having student teacher ratio of 15:1.
2. The validity of the Management Committee is a relevant factor for continuance of grant to an institution.
3. The pupil teacher ratio is to be maintained. In case there is less student proportionate to standardized number of teachers, then there should be transfer of surplus teaching staff to other institutions of need to avoid idle payment.
