On the recommendation of the Odisha Public Service Commission, Cuttack vide their letter No. 9244/PSC, dated 18.12.2023, Dr. Shambhavi Jha, OPSC Sl. No. 472, UR-F, DOB-04-04-1995, At- House No. 50, Laxmi Nagar, Rajnandgaon, Chhattisgarh-491441, Mail- shambhavi.poo44@gmail.com is hereby appointed as Medical Officer in the rank of Group-'A' (Junior Branch) of Odisha Medical & Health Services Cadre under Health and Family Welfare Department and posted to Puri district in the scale of pay of Rs. 56,100/- (Level-12, Cell-1 of the Pay matrix) as per the ORSP Rules, 2017 and other allowances as admissible and sanctioned by the Government from time to time. She shall be on probation for a period of two years from the date of joining the post.

1. The appointment is purely temporary and terminable at any time without prior notice and without assigning any reason thereof.
2. The appointee who will fail to produce the original Certificates as per the OPSC Advertisement No. 14 of 2023-24 before the concerned CDM & PHO and in the event of any forged document comes to the notice of the verifying authority, her appointment order will stand terminated.
3. The appointment is subject to her medical fitness to be determined by the Medical Board and her characters, antecedents are found to be satisfactory after verification. In case, adverse reports are received, the service of the candidate concerned would be terminated forthwith.
4. As reported by the Odisha Public Service Commission, **Dr. Shambhavi Jha** bearing following Roll No. 102334 has not passed Odia up to M.E. School Standard.

As per the Rule 7(v) of Odisha Medical & Health Services (Method of Recruitment and Conditions of Service) Rules, 2017 and Odisha Medical & Health Services Amendment (Method of Recruitment and Conditions of Service) Rules, 2020, **she shall be allowed to pass the said examination conducted by Board of Secondary Education, Odisha within 04 (Four) years of joining in the service failing which no further increment shall be sanctioned and no promotion to the rank of Group-A (Senior Branch) will be made.**

5. No T.A. / D.A. will be allowed to join the place of posting.
6. The Medical Officer allotted to the district will be posted to the health facility of the district by a Committee under the Chairmanship of Collector-cum-DM and the CDM & PHO will be the convener of the committee along with wing officers as members.
7. The Medical Officers who are continuing their PG study / Superspecialisation course in any institution and Senior Resident / contractual Assistant Professor only in the Government Medical Colleges of Odisha and selected for regular appointment on the recommendation of the OPSC may be allowed to join at their place of posting in the periphery and may be relieved by the concerned CDM &

PHO on the next day in order to enable them to continue their PG study, Superspecialisation, Senior Resident ship or contractual Assistant Professor in the respective Medical Colleges on submission of an undertaking to join and serve under the State Government on completion of their higher studies.

8. The Medical Officers who are working as Tutor / JR in any institution and SR / Assistant Professor in the institutions other than the Government Medical Colleges of Odisha and selected for regular appointment on the recommendation of the OPSC may be allowed to join at their place of posting in the periphery after their resignation from the said posts.
9. The Medical Officer while working in the periphery service in case selected for PG study / higher study / Senior Resident ship in future will not be relieved by the concerned CDM & PHO to join the course without obtaining prior permission of the Government.
