IMPORTANT INSTRUCTIONS

1. <https://jcportal.odisha.gov.in> is the official Online Counselling Application for the counselling of Multipurpose Health Worker (Female) Level-II to be appointed under Directorate of Family Welfare, H&FW Dept., Govt. of Odisha. Read the Instructions carefully before filling your Online Counselling Application form.
2. Before filling in the Online Counselling Application, the candidate must use the same Mobile number and Email ID submitted during their Online application to OSSSC, Odisha. No other new mobile number or Email id will be added/ altered. Directorate of Family Welfare, Odisha will not be responsible for incorrect mobile number or Email ID.
3. The candidates must not share their Roll number and OTP with anyone.
4. The applicants are advised to fill their choice particulars on the portal carefully as submission of wrong information or option may lead to rejection through computer-based allocation. Option once submitted cannot be edited/ alternated in any circumstances.
5. The candidates are NOT required to send the printouts of their online counselling applications either to Directorate of Family Welfare or any other Office. However, the Application will not be treated as submitted unless and until it is available under 'Finally Submitted Application' Tab before the closing date and time.
6. The candidates are required to retain a print out of their finally submitted counselling application form for future references.
7. The candidates are advised to give maximum number of choices, preferably the number of choices as per his/her position in the priority list for getting allocated as per their preferences. Submitting less choices or non-submission of choices will lead to auto allocation of choices by Computer. No request in this regard will be entertained.
8. The computer-based counselling process includes assigning applicants to a particular post.
9. Application once submitted cannot be edited / withdrawn.
10. Candidates participating in the counselling are requested not to wait till the last-minute rush.
