On the recommendation of the Odisha Public Service Commission, Cuttack pursuant to the Advertisement No. 38 of 2023-24, the following 12 (Twelve) number of candidates are hereby appointed as Psychiatric Social Worker in the rank of Group - 'B' of State Service for Drug-De-addiction Centres (DAC) under Health & Family Welfare Department in the Scale of pay of Rs.44,900/- (as per 7th Pay Commission) in Level-10, Cell-01 of Pay Matrix of ORSP Rules, 2017 with usual dearness and other allowances as may be sanctioned by the Government of Odisha from time to time.

1. The appointment is purely temporary and terminable at any time without prior notice and without assigning any reason thereof. The appointment is only valid subject to conditions of valid verification and correctness of the certificates ensured by the competent authority.
2. The appointees shall be on probation for a period of one year.
3. The appointments are subject to their Medical Fitness to be determined by the Medical Board and their characters; antecedents are found to be satisfactory after verification. In case, adverse reports are received, the services of the candidates concerned would be terminated forthwith.
4. The detailed place of posting has been made by way of counselling conducted by the Director, Public Health, Odisha, Bhubaneswar as per the guidelines issued vide Resolution No-14327/Gen, dated-04.07.2017 of General Administration and Public Grievance Department.
5. They are posted to the Drug-De-addiction Centres (DAC) as mentioned against each in the vacant posts of Psychiatric Social Worker as per the below table.
6. The appointees shall produce the Original Registration Certificates as per the OPSC Advertisement No.38 of 2023-24 before the concerned Dean & Principal/ Director/CDM & PHOs within 30 days of issue of this Notification, failing which appointment orders will stand cancelled.
7. The appointees are hereby directed to join at their place of posting within 30 (Thirty) days positively from the date of issue of the notification, after obtaining the orders of acceptance of their resignation/relieve order from the competent authority, if they are already appointed permanently/ substantively in any cadre of the State or Central Government.
8. The concerned Dean & Principal/ Director/CDM & PHOs are hereby requested to accept the joining report of the appointees after due verification of relieving orders/ acceptance of their resignations, if any, by observing due procedure as per Rules and Regulations in case of the appointees appointed permanently/ substantively in any other cadre of the State or Central Government.

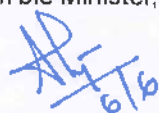

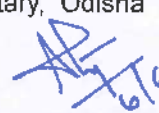

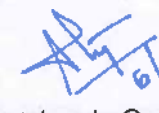
