Sub: Extension of last date for submission of online transfer applications through Transfer Portal.

Madam/Sir,

In continuation of this Department Office Memorandum No. 1104/H., dated 12.01.2026 regarding submission of online transfer applications through the Transfer Portal, I am directed to inform that the **last date for submission of online transfer applications has been extended up to 15th March, 2026.**

All eligible officers and employees under the Health & Family Welfare Department who intend to apply for transfer are hereby advised to submit their applications through the designated Transfer Portal within the extended timeline. No applications shall be entertained after 15.03.2026.

Officers and employees who have already submitted their applications may modify the same during the extended period, if necessary. Those who intend to submit fresh applications must ensure that their HRMS data is duly updated before submission. Similarly, applicants who have already applied are also required to verify and ensure that their HRMS particulars are complete and up-to-date. Applications containing incomplete or incorrect HRMS information shall be liable to rejection.

All concerned authorities are requested to circulate this information among all officers and staff under their administrative control for wide publicity and ensure strict compliance.
